

# 2018/19 CPO RAFFLE RULES



1. Subject to all applicable laws, including the *Criminal Code* (Canada), the *Gaming and Liquor Act*, the *Gaming and Liquor Regulation (Alberta)*, these Rules govern all aspects of the Raffle Draw. In the event of any inconsistency between the Rules and conditions/explanations appearing on any other document, these Rules shall take precedence.
2. By purchasing a Raffle Ticket, the Ticket Buyer agrees to be bound by these Rules.
3. The Calgary Philharmonic Orchestra's Raffle Ticket License Number is **501576**.

## BUYING RAFFLE TICKETS:

4. This Raffle draw is valid in the province of Alberta only. Ticket sales are restricted within Alberta.
5. Raffle tickets shall not be sold to a natural person under 18 years of age, and ticket sellers must advise ticket buyers that the person whose name appears on the ticket must be 18 years of age or older (due to the requirements of the Public Trustee Act).
6. Calgary Philharmonic Society staff are not eligible to enter the draw.
7. Only one purchaser name may be written on a ticket. In the event a winning ticket stub has more than one name on it, the Calgary Philharmonic Society shall award the prize to only the first name identified on the ticket. The Calgary Philharmonic Society and the AGLC are not responsible for any disputes that may arise between the different individuals whose names appear on the ticket stub.
8. Raffle Tickets must be paid for by cash, cheque or credit card, and payments are payable to the Calgary Philharmonic Orchestra Society. Ticket sales are final and non-refundable once payment has been confirmed. Cheques will not be accepted as a method of payment after May 31, 2019.
9. A Ticket Buyer must provide the Calgary Philharmonic Society with his or her full name, residential address, and residence telephone number, which becomes part of the Raffle Record. The Calgary Philharmonic Society retains the Raffle Record for two (2) years from the draw date and abides by applicable privacy legislation.
10. There are only 4,950 Raffle Tickets printed and available for sale. There is no minimum number of tickets to be sold.

## THE DRAW:

11. A random draw for the winning tickets shall be made on June 13, 2019 at the Calgary Philharmonic Orchestra located at 205 – 8<sup>th</sup> Avenue SE, Calgary, AB, T2G 0K9.
12. Two (2) executive members of the Calgary Philharmonic Society, along with three members of the public will be present to witness the draw.
13. The person making the draw cannot have a ticket or an interest in the draw.
14. Draw will be announced to the public on hand and winners will be contacted by phone or mail.

## THE PRIZE:

15. Prize consists of:

- **Round trip Business Class tickets for two (2) from Calgary to Buenos Aires**, provided by CPO. The Winner has 1 year to claim prize (June 13, 2019 to June 14, 2020). All travel must be completed by October 31, 2020.

16. The prize booking is a one-time transaction only.

17. Opportunity to extend the Winner's vacation and add additional tours at Winner's expense.

19. The retail price of the trip will be **\$22,000**.

20. All additional fees, costs, expenses, including but not limited to taxes, airport taxes, duties, gratuities, insurance, spending money, change/cancellation fees, trip extension, excess luggage, warranties, damages for any loss or injury, incurred after the transfer of the Prize to the Winner, shall be the responsibility of the Winner.

21. If the Winner of the prize has not redeemed the prize within one year and one day of the draw (June 14, 2020), the prize is forfeited and no further compensation will be made. Once the prize has been claimed, the booking of the trip can extend past the June 14, 2020 date; all travel must be completed by October 31, 2020.
22. There will be no cash in lieu of the prize. The prize must be accepted as awarded and cannot be exchanged for cash.
23. Confirmed Winner is responsible for all costs and expenses that are not payable at the time travel is booked including without limitation: ground transportation from the Winner's home to and from departure airport, airport parking charges, cancellation fees, all other applicable taxes, excess baggage charges, health or other inspection fees, fuel surcharges and other non-ticket costs or charges, telephone, Internet and fax charges, in-room mini-bar and snacks, meals, beverages including alcoholic beverages, and gratuities, and are the responsibility of the confirmed Winner and his/her guest. If a car rental is involved as part of the redeemed points, gas is not included and driver must be between the ages of 25 and 70.
24. The confirmed Winner and his/her guest are solely responsible for obtaining all the necessary international travel and medical documentation as required, as well as any immunization required for travel to a foreign destination. The Calgary Philharmonic Society shall not be liable or responsible for ensuring that the confirmed winner and companion if any, is eligible for travel.
25. Winners are solely responsible for obtaining proper travel documents, passports, and identification prior to travel. The Calgary Philharmonic Society shall not be liable or responsible for ensuring that the Winner and companion if any, is eligible for travel.

## PRIZE REDEMPTION:

26. The Winner does not have to be present to collect the Prize. The Calgary Philharmonic Society will contact the Winner at the contact information provided on the Raffle Ticket, and if the Winner cannot be located within one (1) year of the Draw Date, unclaimed prizes will revert back to the property of the Calgary Philharmonic Society (CPS) with AGLC approval.
27. Notice advising ticket purchasers, in the event a winning ticket stub has more than one name on it, the Calgary Philharmonic Society shall award the prize to only one of the individuals identified on the ticket, and that the Calgary Philharmonic Society and the AGLC are not responsible for any disputes which may arise between the different individuals whose names appear on the ticket stub.
28. By accepting the Prize, the Winner agrees and acknowledges that the Calgary Philharmonic Society can advertise the Winner's full name and city of residence on its web site and in other media, including press releases without any payment, compensation or liability to the Winner.
29. To book the travel package, the Winner must contact the Calgary Philharmonic Orchestra's Development Officer at (403) 571-0267. At the time of booking, the Winner must present the Prize Certificate (which shall be authenticated by the CPO), and may be required to provide CPO with proof of identification.

## LIMITATION OF LIABILITY:

30. The Calgary Philharmonic Society is not responsible for contacting or forwarding the Prize to the Winner who leaves unclear or incomplete contact information, although efforts will be made to identify the winner on our behalf.
31. The winner must sign the Prize Affidavit and Eligibility Release form releasing the Calgary Philharmonic Society and its partners from any and all liability arising out of, pursuant to, or as a result of carrying out the Raffle, including liability arising from the acceptance of, and participation in, the Prize.
32. By accepting the Prize, the Winner agrees to hold the Calgary Philharmonic Society, its agencies, affiliates, subsidiaries, agents, advertising and promotion agencies, and anyone else involved in the development, production or handling of the Raffle and their respective directors, officers, employees, volunteers and assigns, harmless against any and all claims and liability arising out of use of the Prize, including, but not limited to, travel-related injuries and/or death.
33. The Winner assumes all liability for any injury or damage caused, or claimed to be caused, whatsoever and howsoever arising, by participation in this Raffle or use or redemption of The Prize.
